The Right to Counsel Coalition of NYC is made up of tenant organizing groups, tenant advocates, law schools and legal services organizations. We are working together to ensure that our city's housing courts are a place of fairness, justice and equity. We do not support forced displacements that can and should be prevented and we believe that safe and affordable housing is central to our city's future. We are working on establishing a right for New York residents to be represented by licensed, qualified and experienced attorneys when they go to housing court to defend their rights.



## Right to Counsel Town Hall Meetings

Tenants Share Their Stories and Show Their Support for Right to Counsel

March-April 2015



- Nearly 30,000 families were evicted in New York City last year. 90% of them did not have an attorney.
- There are over 60,000 people in our shelter systems. Evictions are the number one reason people go into shelters.
- 52% of evicted tenants come from rent stabilized apartments.

Increased funding for legal services isn't enough. Tenants deserve a RIGHT to counsel.

This spring, the Right to Counsel NYC Coalition organized town hall meetings in the Bronx, Brooklyn, Manhattan and Queens. Tenants came to learn about Intro 214, an exciting bill that would make New York City the first city in the nation to guarantee legal representation for tenants facing the loss their home. Every 4.5 minutes someone in NYC is evicted. Every 4.5 minutes, justice is denied to New Yorkers. People deserve the right to defend their most important need—their home.

At every town hall, tenants performed skits showing a typical day in housing court: the long lines, intimidating landlord attorneys, and unhelpful court clerks. This experience in housing court is so common that hundreds of tenants nodded acknowledging this common experience. Tenants also worked in small groups to strategize how to mobilize support to ensure that Right to Counsel passes!

In the span of a little over a month, close to 500 tenants dedicated their time and energy to learn about what right to counsel is, what it isn't, to share stories and to strategize about how we can build power to make sure Intro 214 passes!
